

The first quarter Auto Club Alumni Luncheon, held January 23, 2025, at the Knott's Berry Farm Hotel, is typically one of the most well-attended alumni events, as retirees have a chance to hear the CEO and other members of the ACE executive team discuss "the state of ACE."



Scale of ACE

Our size helps to protect us and our members and insureds. ACE is the largest club in the AAA Federation, with 31.4% of all members. We now operate in 23 states and serve 17.9 million members.

Our scale helped us weather several challenges, including continued wage and cost inflation, significant insurance rate increases, and insurance losses and catastrophes.

Achievements in 2024

We are proud to point out 2024's wins, which include the following:

Our MyClubCares community impact program. Through MyClubCares, our employees dedicated 41,512 volunteer hours, supported 1,500 non-profit organizations, and raised more than \$1 million to support United Ways nationwide.

Our Business Resource Groups (BRGs), now numbering 9. BRGs help us create a work environment where everyone feels encouraged to share their voice and advance their

career. BRGs are volunteer employer-recognized workplace groups organized around an aspect of shared diversity and experiences. They focus on cultural education, employee development, and community impact. BRGs provide leadership development opportunities for high-potential diverse employees and create strategic drivers for recruitment and retention.

Growth. Membership continues a steady trend up. ACE now serves 17.9 million members. ACE Travel Revenue saw increases as well, with \$132 million in Travel Agency commissions. Insurance also saw growth, with 4 million total policies in effect. AM Best ranked ACE #10 of Top U.S. Auto Insurance Companies for market share, while our Service Quality is the highest among other large AAA clubs, holding steady at 85% for Automotive Service Quality Overall Satisfaction.
